SUBJECT

Survey on Current Prices of COVID-19 Test

The Department of Health (DOH) issued Department Memorandum (DM) 2020-0439 titled "Omnibus Interim Guidelines on Prevention, Detection, Isolation, Treatment, and Reintegration Strategies for COVID-19," dated October 6, 2020, to provide guidelines on surveillance, screening, contact tracing, quarantine or isolation, and testing as part of the COVID-19 response. The said DM provided the recommendations on the rational use of the tests for COVID-19, whether RT-PCR, antigen or antibody testing.

Reports/complaints have been received by the Department on the variability in the testing fees for COVID-19 tests. To protect the public from the exorbitant pricing of these tests, the Health Facilities and Services Regulatory Bureau (HFSRB) was tasked to conduct a survey of the prevailing prices by the different laboratories, whether doing tests to detect SARS-COV-2 using RT-PCR and presence of antigen or antibody.

In order to determine the prevailing rates for these tests, all COVID-19 laboratories and other facilities performing antigen and antibody tests are hereby directed to submit to HFSRB the accomplished template provided (see Annex A) on or before October 29, 2020 at this email: hfsrb.sdd@gmail.com
